#### What is a Maryland Justice Passport?

A Maryland Justice Passport is a digital portfolio of information to assist Marylanders seeking legal help.

#### Who Can Make a Passport?

Any Marylander facing a civil legal issue can make a Justice Passport.

#### What does a Passport Do?

A Justice Passport can be used to get referred to service providers, store important documents, and keep all case information organized.

#### Who Can See My Passport?

You choose who can see your Passport. You can share your Justice Passport with service providers so they can quickly see case information and assist you.

#### How Do I Make a Passport?

You can get a Justice Passport by signing up online, scanning the QR code below, or contacting a participating organization.
